2 Definitions

Company requirements include the policy, procedures, and methodologies of the company. They include legislative and regulatory requirements that may apply across the company or to a specific site. Requirements are documented in the company's health and safety plans, traffic management plans, contract work programmes, quality assurance programmes, policies, and procedural documents. Forest users may refer to iwi, principals, employers, workers on site, people on site or passing through, landowners, harvesting contractors, or transport companies. Job prescriptions are those given to the operator prior to undertaking a job. They may include site safety instructions, mapping information, contract drawings, and written memos.

Manufacturer's instructions may include specifications, installation, handling, use and maintenance instructions, and safety data sheets.

Maintain water and sediment control structures.

Performance criteria

3.1 Location position, and alignment of water control and sediment control structures are maintained in accordance with forest user requirements and manufacturer's instructions.

Range maintenance activities may include but are not limited to – cleaning and/or clearing, preventative maintenance, repairs.

Carry out other maintenance activities for forestry infrastructure.

Range contexts for maintenance activities include but are not limited to – accessibility, compliance, drainage, stability.

Performance criteria

4.1 Road surface is maintained in accordance with forest user requirements.

Range may include but is not limited to – repairing of potholes, selection of aggregate, surface preparation.

- 4.2 Tracks, landings, river crossings and roadside vegetation are maintained in accordance with forest user requirements.
- 4.3 Machinery is operated safely in accordance with company requirements and manufacturer's instructions.
- 4.4 Maintenance reporting is completed in accordance with company requirements.
