### 2 Definitions

Job specifications refer to instructions (oral, written, graphic) and may include any of the following: manufacturer instructions; design drawing detail specifications; specifications from a specialist source such as an architect, designer, engineer, or a supervisor; and site or work specific requirements.

Maintain may refer to all or any of repair, upgrade, alter, remove, replace.

- 3 Candidates must hold a current limited certificate trainee authorisation or exemption under supervision as issued under the Plumbers, Gasfitters, and Drainlayers Act 2006.
- 4 Assessment information

All work must be completed in accordance with job specifications and relevant standards and codes.

5 Range

Pipework may include but is not limited to – copper, mild steel, stainless steel, polyethylene, a proprietary system, multi layer; and associated fittings and/or fixtures. Jointing methods are determined according to the material being joined and may include but are not limited to – brazed, tapered thread, compression type fitting, flange.

6 Level of performance

To achieve this standard the candidate must be capable of consistently performing the requirements:

- to current and relevant legislation, standards and codes (including safety);
- in an environmentally sustainable manner;
- within an acceptable timeframe;
- in the workplace;
- in different and unfamiliar contexts.

# Outcomes and performance criteria

## **Outcome 1**

Maintain consumer gas pipework.

## Performance criteria

- 1.1 Inspect pipework, fittings, supports and proper protection to determine their physical condition.
- 1.2 Test the installation for gas tightness in accordance with AS/NZS 5601.1:2013.
- 1.3 Identify causes of faults and possible means of rectifying faults.

Range may include but is not limited to – blockage, leaks, physical damage, corrosion, pipe-sizing.

1.4 Repair or remedy faults in accordance with maintenance requirements.
