- 2 Definitions
Job specifications refer to the standard requirements of the job being undertaken.
Workplace policies and procedures refer to the documented procedures and policies providing guidelines of the tasks and activities carried out in the workplace. This typically includes relevant health and safety policies to manage risk in the workplace.
- 3 This unit standard applies to assembling sail accessories, making sail bags and applying U.V. protection to a sail. Accessories may include but are not limited to: sail hardware, battons, slides/hanks.

Outcomes and performance criteria

Outcome 1

Identify sail accessories.

Performance criteria

- 1.1 Customer requirements and job specifications are established and verified in accordance with design specifications.
- 1.2
- 1.3 Accessories are identified in accordance with job specifications.
- 1.3 Lists or patterns for accessories are prepared in accordance with job specifications.

Outcome 2

Assemble accessories.

Performance criteria

- 2.1 Accessories are assembled in accordance with job specifications.
- 2.2 Checks for defects in items and materials are carried out and when identified they are rectified in accordance with workplace policies and procedures.

Outcome 3

Prepare and make sail bags.

Performance criteria

- 3.1 Material and accessories are selected in accordance with job specifications.
- 3.2 Material is laid out and inspected for defects.
- 3.3 Material is measured, marked and cut, in accordance with job specifications.
- 3.4 Material is assembled and stitched in accordance with job specifications.
- 3.5 Fastening systems and accessories are fitted to the bag in accordance with job specifications.
- 3.6 Finished bag is checked and remedial action is taken if required to ensure job specifications are met.

Outcome 4

Prepare and apply U.V. protection to a sail.

Performance criteria

- 4.1 UV protection method is identified in accordance with job specifications.
- 4.2 Materials are selected, assembled and prepared in accordance with job specifications.
- 4.3 Defects in materials are identified and rectified in accordance with workplace policies and procedures.
- 4.4 UV sail protection materials are applied to a sail in accordance with job specifications and workplace policies and procedures.
- 4.5 Finished UV protection is checked and remedial action is taken if required to ensure job specifications are met.
