#### Outcome 3

Restore airworthiness of aircraft reciprocating powerplants.

#### Performance criteria

- 3.1 Methods of rectifying defects are determined.
- 3.2 Replacement parts are procured and verified as authentic and serviceable.

Range identify, inspect.

3.3 Defects are rectified.

- 3.4 Powerplants are assessed to verify serviceability.
- 3.5 Servicing activities required as a consequence of the maintenance activity are completed.

Range may include but are not limited to – serviceable, unserviceable,

surplus, waste, scrap, hazardous.

4.4 Documentation is completed.
