1 Definition

The definition of a *crane* is as given in the Health and Safety in Employment (Pressure Equipment, Cranes, and Passenger Ropeways) Regulations 1999.

- This unit standard is aimed at giving candidates sufficient skills to understand the principles of mobile cranes mechanical engineering, the defects that are likely to develop, and the corrective action which needs to be taken.

# Outcomes and evidence requirements

#### **Outcome 1**

Diagnose and rectify mechanical faults in mobile cranes or track crawler cranes.

Range evidence is required for at least two faults for each location.

## **Evidence requirements**

- 1.1 Faults in the crane carrier are diagnosed and rectified in accordance with equipment manufacturers' recommendations and company standards.
- 1.2 Faults in the upper works are diagnosed and rectified in accordance with equipment manufacturers' recommendations and company standards.

#### Outcome 2

Test and document repairs to mobile cranes or track crawler cranes.

## **Evidence requirements**

2.1 Repairs are tested and documentation completed in accordance with equipment manufacturers' recommendations and company standards.
