- 1.4 The requirements for finance contracts are identified in accordance with the Credit Contracts and Consumer Finance Act, and the Fair Trading Act.
- 1.5 Written information required to be displayed on a Supplier Information Notice is identified.

Range vehicle details, consumer rights.

1.6 All offences and their penalties under the MVSA, Part 4 – Enforcement, are identified.

Range infringement offences, specified offences.

#### Outcome 2

Demonstrate knowledge of the Personal Property Securities Register.

#### Performance criteria

- 2.1 The importance of carrying out Register checks in order to enable secure transactions during the buying and selling process is explained.
- 2.2 The circumstances when more than one check is necessary during the buying and selling process are identified.
