- 1.2 Documentation for the receipt of explosive ordnance and associated components is processed.

Outcome 2

Store explosive ordnance and associated components.

Performance criteria

2.1 Storage facilities are inspected.

Range storage facility license and/or authorisation current, buildings and fences secure, firefighting appliances serviceable.

2.2 Explosive ordnance and associated components are loaded onto and unloaded from transport vehicles and stored.

2.3 Stocks of explosive ordnance are controlled by rotating stores.

2.4 Explosive ordnance and associated components are segregated and isolated.

Range may include but is not limited to – restricted-in-use, constrained lots, unserviceable, blacklisted, experimental, trials, lifed items.

Outcome 3

Issue explosive ordnance and associated components.

Performance criteria

3.1 Explosive ordnance and associated components are issued.

3.2 Explosive ordnance and associated component's issue documentation is processed.
