- 2.2 Check and calibrate drive belt tensions, cable tensions and adjustments in accordance with manufacturer's instructions.
- 2.3 Check feed dispensing gear or valves are working in accordance with manufacturer's instructions.
- 2.4 Identify and report any feeding system problems in accordance with workplace procedures.

Outcome 3

Operate a feeding system for pigs.

Performance criteria

- 3.1 Ensure feed hoppers are filled with feed prior to activating the system in accordance with manufacturer's instructions.
- 3.2 Activate the feeding system in accordance with manufacturer's instructions.
- 3.3 Check to ensure pigs are fed the specified ration in accordance with workplace procedures.
- 3.4 Ensure that all feed dispensers or valves close after feed has been dispensed, and that the system switches off in accordance with workplace procedures.
