2 Definitions

Establishment requirements may include but are not limited to: establishment performance guidelines and standards; equipment manufacturer's procedures and specifications; Government and local body legislation.

Licensed premises – any premises in which a licence is held as defined in the Sale and Supply of Alcohol Act 2012.

3 All tasks are to be carried out in accordance with establishment requirements.

Outcomes and performance criteria

Outcome 1

Demonstrate knowledge of alcohol and intoxication in licensed premises.

Performance criteria

1.1 Effects of alcohol on different customer types are identified and described.

Range customer types include but are not limited to –age group, gender, body type;
effects may include but are not limited to – blood alcohol content levels.

1.2 Interaction of alcohol with other drugs is described.

Outcome 2

Demonstrate knowledge of server responsibilities in licensed premises.

Performance criteria

2.1 Offences and penalties for alcohol service are identified and described.

Range may include but is not limited to – inappropriate promotions, sale of a banned alcohol product, sale or supply of alcohol to minors, sale or supply to an intoxicated person, being intoxicated on duty, refusal to supply licence and assistance to police.

2.2 Server responsibilities are identified and described.

Range includes but is not limited to responsibilities in relation to – self, the establishment in which drinks are served, the customer, the community.

Outcome 3

Demonstrate knowledge of preserving a responsible drinking environment as a server in licensed premises.

Performance criteria

3.1 Server intervention and substitution techniques are described.

Range techniques may include but are not limited to – slowing service, providing alternatives, service refusal.

3.2 The need to promote the availability of food, low and non-alcoholic drinks, and alternative transport options to customers is identified and described.
