2 Definitions

Animal facility refers to a facility such as an animal boarding facility, a veterinary clinic, pet shop, or animal welfare facility.

Workplace procedures refer to the documented procedures for animal care, handling, and ethical behaviour codes required by the employer of the animal facility and must be consistent with equipment manufacturer's recommendations.

- 3 For the purposes of assessment:
 - evidence for the practical components of this unit standard must be supplied from a workplace or organisation.
 - evidence must be presented in accordance with workplace procedures.
 - for assessment of Outcome 3, the candidate is expected to meet the daily care requirements of a healthy cat in an animal facility or other commercial setting such as an animal facility over a period of at least three days. The three days are not required to be consecutive.
 - practical handling must be assessed using a live cat.

Outcomes and performance criteria

Outcome 1

Identify cats by breed, age, sex, and individual characteristics.

Performance criteria

1.1 Identify cats in terms of their breed.

Range may include but is not limited to – domestic short hair, domestic

long hair, Siamese, Burmese, Birman, Abyssinian, Devon rex,

Cornish rex, Persian, chinchilla; evidence is required for at least eight.

1.2 Identify cats in terms of their age and sex.

Range kitten, adult, senior;

male - neutered, entire;

female.

1.3 Document a cat's individual characteristics for the purpose of identification for admission to an animal facility.

Range includes but is not limited to – colour, weight, distinguishing

features:

may include – name, tags, microchip.

Outcome 2

Handle and restrain a cat for routine activities, and describe procedures for handling cats in non-routine situations.

Performance criteria

2.1 Handle a cat safely for routine activities in a secure environment.

Range top and front-loading cages – remove from cage, replace in cage;

carry cat out of cage.

2.2 Restrain a cat safely for clinical examination.

Range may include but is not limited to clinical examination for –

temperature, heart rate, eye examination, ear examination;

evidence is required for at least three.

2.3 Describe procedures for handling fractious, pregnant, injured, senior, and unwell cats.

Outcome 3

Feed, water, groom, and transport a healthy cat.

Performance criteria

- 3.1 Feed and water a cat.
- 3.2 Maintain feeding equipment.
- 3.3 Groom a cat.
- 3.4 Maintain grooming equipment.
- 3.5 Transport a cat safely within the animal facility.
