### Outcomes and performance criteria

#### Outcome 1

Remove oyster (tio) spat bundles from holding racks and/or storage area, and maintain throughput.

#### Performance criteria

- 1.1 Remove spat bundles from holding racks and/or storage area.

## 1.2 Maintain throughput.

**Outcome 2**

Break up oyster (tio) spat bundles, identify bundles with insufficient or excess spat settlement, fasten onto growing racks, collect and store waste materials, and maintain throughput.

**Performance criteria**

- 2.1 Break up spat bundles.
- 2.2 Identify spat bundles with insufficient or excess spat settlement and take required action.
- 2.3 Fasten to growing racks firmly, using the appropriate attachment method.
- 2.4 Collect and store waste materials.
- 2.5 Maintain throughput.
