# 3 Definitions

Industry requirements refer to relevant policies, processes, methodologies, industry codes of practice, site specific health and safety plans, standard operating procedures, site safety plans, quality plans, work plans, traffic management plans, contract work programmes, job safety analysis, safe work method statements, job instructions, manufacturer's requirements, contract specifications, manuals, procedural documents.

TA/RC refers to territorial authority and/or regional council.

Thinning means to remove, trim or top trees from a shelter belt and/or plantation and does not exclude other agricultural contracting situations requiring thinning. Trees may include vines.

The range for this unit standard is two of trimming, topping, or removing trees from shelter belts and/or plantations.

# Outcomes and performance criteria

#### **Outcome 1**

Select and prepare thinning equipment and machinery.

# Performance criteria

1.1 Equipment and machinery appropriate for the work are selected.

Range may include but is not limited to – chainsaw, shredder, stump grinder, log skidder, axe, lopper, tracked tractor, excavator, loader; evidence of three pieces of equipment or machinery is required.

- 1.2 Selected equipment and machinery are checked for condition, damage, wear, and faults; problems are identified; and corrective action is taken.
- 1.3 Checks are made, and any necessary actions are taken, or adjustments made to ensure the mobile machinery complies with legal requirements for operator health and safety.

#### Outcome 2

Carry out field preparation.

#### Performance criteria

- 2.1 Hazards are identified and controlled.
- 2.2 Removal of trees to maximise survival and optimum mature shape for remaining trees is confirmed in accordance with client requirements.
- 2.3 Disposal options for thinnings, and/or stumps are identified, and the preferred option is decided upon in accordance with client and TA/RC requirements.

#### Outcome 3

Thin shelter belts and/or plantations.

### Performance criteria

- 3.1 Shelter belts and/or plantations are thinned with no risk of harm to people or animals and with minimal damage to adjoining trees or property structures.
- 3.2 Thinnings and/or trees are disposed of in accordance with client and TA/RC requirements.

## **Outcome 4**

Carry out post-operational procedures.

# Performance criteria

- 4.1 Shut-down procedures are carried out.
- 4.2 Any damage or faults including any missing, bent, broken, or loose parts are identified and are repaired, replaced, or reported.
- 4.3 Equipment and machinery are stored.
- 4.4 Documentation for the operation is complete.
