2 Definitions

Emergency – a sudden, serious, unexpected or impending, and sometimes dangerous situation involving a horse or horses that may cause or have already caused injury or loss of life and requires immediate action.

Workplace procedures – the procedures and standards set by the client or employing organisation. Workplace procedures should reflect equipment manufacturer's

requirements, and current legislation.

- 3 For the purposes of assessment:
 - evidence must be presented in accordance with workplace procedures.
 - assessment for the practical components of this unit standard must be supplied from a commercial horse enterprise or recognised voluntary equine organisation.

Outcomes and performance criteria

Outcome 1

Identify potential hazards involving horses and implement measures to ensure safety of horses and people in and around the horse facility.

Performance criteria

- 1.1 Evaluate horse facilities for suitability of purpose for the operator and horses.
- 1.2 Identify potential hazards to horses and people in and around the horse facility.
- 1.3 Implement safety measures to control any potential hazards to horses and people.

Outcome 2

Demonstrate knowledge of the actions to take in the event of an emergency involving horses.

Performance criteria

- 2.1 Identify the purpose of individual items in a comprehensive First Aid kit for horses.
- 2.2 Describe the workplace procedures for immediate course of action resulting from an emergency situation.

Outcome 3

Provide assistance to the veterinarian while veterinary treatment is being carried out.

Performance criteria

- 3.1 Hold the horse for the veterinarian and apply restraints.
- 3.2 Lead the horse out to allow assessment of action.

Outcome 4

Describe and monitor health status of horses in training.

Performance criteria

4.1 Describe the reasons for monitoring horse health when in training.

4.2 Monitor and report health status of horses to the supervisor.

Outcome 5

5.1 Carry out ongoing care and administer treatments for a horse following sickness or injury.

Range may include but is not limited to – topical treatment, oral treatment,

foot treatment, poultice, bandaging;

evidence of two is required.

5.2 Observe, record and report horse's ongoing health to the supervisor.
