Range Japanese Agricultural Standard (JAS), Japan Brereton, small end diameter (SED), length.

1.2 Scaling procedures for rule and tape placement, and their interpretation are explained where log shape deviates.

Range out of round log end, the smallest log diameter is not the SED.

Outcome 2

Identify and explain export log grades.

Performance criteria

2.1 Features of export log grades are identified and explained.

Range knot size, sweep, small end diameter, large end diameter, length, wobble, kink, out of round, fluting, off centre pith, pruned logs, unpruned logs, damage.

2.2 Export, pruned, industrial, and pulp grades are identified in accordance with operational requirements.

Outcome 3

Scale export logs.

Performance criteria

- 3.1 The hazards and associated risks specific to log scaling are identified and managed on job.
- 3.2 Equipment is calibrated.
- 3.3 Load docket is verified.
- Out of specification logs are identified for re-grading or re-cutting in accordance with customer requirements.
- 3.5 Parcel of logs is tallied, and large and small ends are verified.

3.6 Scaled loads are labelled and marked to requirement of customer or employing company.

3.7 Work quality is checked to meet the requirements of the operation.

- 4.2 Log inventory is audited at each stage of the marshalling process.
