1.1 Applicable legislation is identified and its application to a site inspection process is described.

includes but is not limited to – HSW Act 2015, HSW (General Risk and Workplace Management) Regulations 2016; HSW (Mining Operations and Quarrying Operations) Regulations 2016; HSW (Worker Engagement, Participation, and Representation) Regulations 2016; HSW (Hazardous Substances) Regulations 2017, HSNO Act 1996, SWIs, approved codes of practice, guidelines.

1.2 The company documentation is reviewed in terms of legislative requirements.

### Range

may include but is not limited to – inspections, site plan, risk assessment, principal hazard management plan (PHMP), principal control plan (PCP), health and safety management plan, standard operating procedures (SOP), trigger action response plans (TARP), resource consents, equipment and instrument certification, training records, internal and external reports.

1.3 Areas of non-compliance in company procedures are identified in terms of legislative requirements.

# Range

may include but is not limited to – routine working place inspections, accident and incident records, plant and equipment safety checks, diesel machinery checks, electrical plant, equipment and reticulation checks, ventilation records and ventilation control devices (VCD) inspections.

- 1.4 Corrective actions for any identified non-compliance are described.
- 1.5 Actions to be taken if the recommended corrective actions cannot be implemented are explained.

#### Outcome 2

Inspect an extractive site's safety and operations.

#### Performance criteria

- 2.1 Site is inspected in terms of safe operation, compliance and non-compliance with company procedures and plans.
- 2.2 Operational areas are inspected to determine if there are safe work processes and that workers have received adequate training.
- 2.3 Selected equipment or machinery is inspected in accordance with a planned inspection or maintenance checklist.
- 2.4 Company procedures and inspections are reviewed for compliance in terms of the selected inspection or maintenance checklist.

#### Outcome 3

Demonstrate knowledge of reporting on the compliance status of an extractive site.

#### Performance criteria

- 3.1 Procedures for reporting non-compliance with company procedures and inspections are described.
- 3.2 A corrective action plan to address identified non-compliance is described, and an agreed reporting system for the action plan is developed and described.
- 3.3 Distribution and filing of non-compliance reports and action plans are described.

### **Outcome 4**

Demonstrate knowledge of auditing and reviewing the health and safety management system at an extractive site.

### Performance criteria

- 4.1 Internal audit procedures are described.
- 4.2 Review requirements are described in terms of legislative compliance.

includes but is not limited to – external audit, Health and Safety at Work (Mining Operations and Quarrying Operations) Regulations 2016.
