Explanatory notes

- 1 Legislation relevant to this unit standard includes but is not limited to the Health and Safety at Work Act 2015.
- 2 Definition
Workplace procedures – procedures used by the organisation carrying out the work and applicable to the tasks being carried out. Examples are – standard operating procedures, site safety procedures, equipment operating procedures, codes of practice, quality management practices and standards, and procedures to comply with legislative and local body requirements.
- 3 This unit standard recognises the additional skills required to tuft carpets on a graphics tufter. The basic tufting skills are recognised in the recommended unit standard.
- 4 Assessment information
All evidence must be in accordance with workplace procedures.

Outcomes and evidence requirements

Outcome 1

Demonstrate knowledge of graphics tufting.

Evidence requirements

- 1.1 Construction characteristics of graphics tufted carpet are described.
- Range pattern formation, pattern sequence.
- 1.2 The function and operation of graphics tufter sections and components are described.
- Range single needle bar, double needle bar, staggered needle bar, straight needle bar, pattern actuating mechanisms.

Outcome 2

Produce graphics carpet.

Evidence requirements

- 2.1 Thread up conforms to work instruction and pattern.
- 2.2 Pattern faults are traced to yarn and rectified according to the design specification.
- 2.3 Broken joins are repaired in sequence required by the pattern.
- 2.4 Yarn sequence at needles is maintained according to pattern.
- 2.5 Carpet meets product specification.
