Outcomes and evidence requirements

Outcome 1

Select carpet and cut samples.

Evidence requirements

- 1.1 Carpet is selected for samples.
- 1.2 Cutting equipment is operated.
Range press, electric cutter, hand cutters.
- 1.3 Sample is cut.

Range cut to size, cut is clean, sample square with pattern or tuft direction.

Outcome 2

Bevel, overlock, or bind carpet samples.

Evidence requirements

2.1 Equipment is operated.

Range bevelling, overlocking, binding.

2.2 Sample sits flat with yarn ends trimmed.

2.3 Overlocking or binding does not fray.

Outcome 3

Label and pack samples.

Evidence requirements

3.1 Labels are applied to sample.

Range labels identify sample, label location on sample, label alignment, label secure.

3.2 Samples are packed.

Range quantity, combination.
