4 The Animal Welfare (Records and Statistics) Regulations 2018 require that any institution, organisation or individual who uses live animals for the purpose of research, testing and teaching, must have an approved Code of Ethical Conduct relating to the welfare and humane treatment of the animals involved. # Outcomes and performance criteria

# Outcome 1

Schedule farm visits, prepare and transport equipment, and conduct self in a professional manner while on farm.

### Performance criteria

- 1.1 Schedule and record arrangements for farm visits in accordance with availability of farmer and self, and requirements of other clients.
- 1.2 Store, handle, and transport equipment sufficient for daily requirements.

Range includes but is not limited to – semen, insemination equipment, recording documents.

1.3 Maintain personal presentation, behaviour, safety, and hygiene while on farm.

### Outcome 2

Prepare cows and equipment for artificial insemination.

### Performance criteria

- 2.1 Lay out equipment.
- 2.2 Check and record cows presented.
  - Range number of cows, cow identification, bull identification, batch identification.
- 2.3 Load semen straws into inseminator in accordance with type of semen, and without affecting viability of semen.

Range fresh, frozen.

2.4 Handle and transport liquid nitrogen and liquid nitrogen banks in accordance with manufacturer's instructions.

# Outcome 3

Artificially inseminate cows to a commercial level.

#### Performance criteria

- 3.1 Clean the vulva area.
- 3.2 Carry out the insemination procedure to a commercial level.

# Outcome 4

Attend to procedures following artificial insemination, and complete records.

# Performance criteria

- 4.1 Discard disposable equipment after use.
- 4.2 Clean re-useable equipment.
- 4.3 Complete records.
