2 Definitions

Equipment refers to items such as pumps, conveyors, lines, and mechanical and/or programmable logic controller (PLC) automated systems.

Organisational procedures refer to documents that include worksite rules, codes, and practices; equipment operating instructions; and production specifications; documented quality management systems; and health and safety requirements.

PPE refers to personal protective equipment such as protective clothing, gloves, safety glasses/headwear/footwear, hearing protection, and safety devices.

Related products refer to beverages, household products, or personal care products.

3 Range

Competence is to be demonstrated on three occasions of operating a silo system for food or related products.

Outcomes and performance criteria

Outcome 1

Use safe working practices.

Performance criteria

1.1 PPE is used in accordance with organisational procedures.

1.2 Work environment is kept clean and free from hazards in accordance with organisational procedures.

Range hazards to – personnel, product, plant.

1.3 Documentation is referred to and/or completed in accordance with organisational procedures.

Outcome 2

Prepare silo system to receive food or related products.

Performance criteria

- 2.1 Silo system is prepared to receive product in accordance with organisational procedures.
- 2.2 Silo system is configured in accordance with organisational procedures.

Outcome 3

Operate silo system to receive food or related products.

Performance criteria

- 3.1 Product is received in accordance with organisational procedures.
- 3.2 Correct product is received and directed to correct silo in accordance with organisational procedures.
- 3.3 Quantity and quality of received product is checked in accordance with organisational procedures.
- 3.4 Any problems associated with receiving products are identified, and rectified and/or reported in accordance with organisational procedures.
 - Range problems may include but are not limited to product quality, product quantity, equipment.
- 3.5 Spillage of product when operating a silo system is minimised in accordance with organisational procedures.
- 3.6 Production downtime due to identifying, and rectifying and/or reporting problems is minimised in accordance with organisational procedures.

Outcome 4

Maintain silo system for food or related products.

Performance criteria

- 4.1 Silo system is maintained in accordance with organisational procedures.
- 4.2 Stock levels in silos are monitored in accordance with organisational procedures.
- 4.3 Stock in silos is maintained at a level sufficient for scheduled and anticipated production requirements in accordance with organisational procedures.
- 4.4 Product wastage due to maintaining the silo system is minimised in accordance with organisational procedures.
- 4.5 Technical non-conformance of silo equipment is identified, and personnel authorised to act are notified in accordance with organisational procedures to minimise damage to the plant and/or product.
- 4.6 Production line requests for product from silo system are actioned in accordance with organisational procedures.
