- comprehensive description of pīngao and where pīngao can be found locally and or regionally and or nationally including kaitiaki contact details.
 - whenu are the same width and lengths;
 - prepared whenu is of an exceptional standard.
- 5 Ākonga will keep a documented photographic visual diary or workbook to assist with assessment and authenticity.
- 6 Definitions
- Environment* refers to where pīngao grows.
- Imagery* may include but is not limited to – photographs, pictures, photocopies, videos.
- Location* refers to where pīngao to be harvested is located.
- Quality* ensures pīngao is graded to complete a task. Includes but is not limited to – broken, infected or discoloured pīngao.
- Quantity* ensures enough pīngao is prepared to complete a kete whakairo.
- Seasonal* refers to when pīngao is harvested.
- Size* refers to whenu width and length.
- Te Whare Pora* – a house or place that is set aside to teach and conserve the art of weaving.
- 7 Referencing
- Referencing of all sources of information is encouraged.
- Referencing will prepare ākonga for the requirements of academic writing.

Prepare pīngao to complete kete whakairo.

3.1 Preparation processes are recorded.

3.2 Whenu are bundled to produce state required for kete whakairo.

3.3 Whenu are hung and stored.
