- 3 For the purpose of this unit standard a flat-based kete does not require a whiri plaited base.
- 4 Demonstrate proficient skills to raranga flat-based kete will be evidenced through:
 - demonstrating some tight weave and standing unsupported;
 - corners are even and balanced;
 - tapiki is tidy and raranga tension is consistent;
 - handles are evenly placed with appropriate lengths for the kete purpose.

- 5 *Demonstrate artistic skills to raranga flat-based kete* will be evidenced through:
 - description of stages of development and kete designs show an in-depth understanding of kete harakeke flat-based construction;
 - kete harakeke flat-based has no gaps and is of an exceptional quality;
 - whiri handles are tight, and are the same width and shape;
 - handles are attached to ensure overall quality of design.
- 6 Ākonga will keep a documented photographic visual diary or workbook to assist with assessment and authenticity.
- 7 Definitions

Features and whakapapa may include but is not limited to artist details, specifications of each kete (dimensions, sinistral and dextral quantities), colours, collection, background or historical information, materials, personal ākonga analysis and reflection.

Imagery may include but is not limited to photographs, pictures, photocopies, videos. *Kete flat based* refers to a woven basket with a base that enables kete to sit upright on a flat surface and unsupported.

Quality ensures harakeke is graded to complete task. Includes but is not limited to broken, infected or discoloured harakeke.

Quantity ensures enough harakeke is prepared to complete flat-based kete. *Seasonal* refers to when harakeke is harvested.

Size refers to whenu width and length.

Te Whare Pora – a house or place that is set aside to teach and conserve the art of weaving.

8 Referencing

Referencing of all sources of information is encouraged. Referencing will prepare ākonga for the requirements of academic writing. All sources of information must be referenced.

Outcomes and performance criteria

Outcome 1

Identify kete flat based harakeke designs.

Performance criteria

1.1 Kete harakeke designs are identified by distinguishing features and whakapapa.

Range evidence of three flat-based kete are required.

Outcome 2

Harvest and prepare harakeke to complete kete.

Performance criteria

- 2.1 Harakeke is harvested in accordance with the tikanga of Te Whare Pora.
- 2.2 Harakeke is prepared in accordance with the requirements of the project.

Range quality, quantity, size.

Outcome 3

Raranga flat-based kete harakeke using takitahi pattern.

Performance criteria

- 3.1 Kete harakeke flat-based stages of development are recorded.
- 3.2 Flat-based kete harakeke is completed.
- 3.3 Whiri handles to suit kete design and purpose.
- 3.4 Handles are attached to kete.
