## Outcomes and evidence requirements

### Outcome 1

Identify the natural habitat and the life cycle of harakeke.

#### Evidence requirements

- 1.1 The natural habitat of harakeke is identified in terms of their environment.
- 1.2 Life cycle of harakeke is described identifying conservation practices and ideal times for cultivation.

### Outcome 2

Harvest and prepare harakeke for whāriki whakairo.

#### Evidence requirements

- 2.1 Sufficient quantity of harakeke is harvested.  
Range quality, width, length.
- 2.2 Whenu is prepared in accordance with project requirements.  
Range boiled and/or dyed, pattern.
- 2.3 Dyes are selected to reflect pattern in keeping with the design and the kaupapa.  
Range natural, synthetic.
- 2.4 Harakeke is preserved in hot water/dye as directed, and in the case of synthetic dyes, in accordance with manufacturer's instructions.
- 2.5 Harakeke is hung to dry to achieve desired results in terms of the project requirements.  
Range shade, texture.
