#### **Guidance Information**

- 1 Quality auditing refers to the objective comparison of:
  - the activities of the auditee against the auditee's quality management systems and
  - the auditee's quality management systems against the applicable relevant regulatory and/or other external standards, and internal requirements.
- Although not prerequisites, Unit 8086, Demonstrate knowledge required for quality auditing, and Unit 8085, Demonstrate knowledge of quality and its management in business contexts contain useful underpinning knowledge for this unit standard.
- 3 Definition

  Organisation refers to a business entity which may be in private, public, or community and volunteer sectors, including in Māori contexts; a business unit, or a special-purpose body.
- Definitions of Quality Management and other specialist Quality Management terms are in AS/NZS ISO 9001:2016 Quality management systems Requirements and associated companion documents available from Standards New Zealand at <a href="https://www.standards.co.nz">www.standards.co.nz</a>.
- 5 Assessment must
  - be in accordance with the AS/NZS ISO 9001:2016 Quality management systems Requirements and with the AS/NZS ISO 19011:2018 Guidelines for auditing management systems, and
  - reflect relevant and current legislation, standards, regulations, acknowledged industry and/or business practices, policies and procedures, and specific legislation relevant to an organisation, including Health and Safety at Work Act 2015, Privacy Act 2020, Standards and Accreditation Act 2015.

This unit standard focuses on the process, not the final outcome of the audit. Candidates must complete at least one full audit (either internal or external) that includes all processes for this unit standard, in an actual workplace. Candidates will work from an audit plan developed against an agreed audit scope. The audit may be completed individually or as part of a team, but each candidate must individually provide evidence of their own performance for assessment against this standard.

Conduct a quality audit for compliance with quality standards.

1.4 Audit requirements are completed, including reporting, negotiating, facilitating

and verifying corrective actions.
