 Classification system the system used to grade hides or skins by characteristics including shape, colour, texture, defects.
- 4 Evidence for this unit standard must be supplied from the candidate's workplace, which is either a tannery or fellmongery.

Outcomes and performance criteria

Outcome 1

Identify and describe animal species used in leather manufacture.

Performance criteria

- 1.1 Identify and describe animal species in terms of their suitability for particular types of leather products.
 - Range species ovine, bovine, cervine, caprine; evidence of three is required.
- 1.2 Identify and describe leather types in terms of the suitability for particular types of end product

Range footwear, clothing, bags, book bindings, fashion accessories, furniture, automobile seats; evidence of three types of leather and the end product is required.

Outcome 2

Identify and describe the equipment used in hide or skin removal for leather manufacture.

Performance criteria

2.1 Identify and describe equipment used to remove hides or skins for leather manufacture.

Range may include but is not limited to – flaymaster, chain puller, shoulder puller, manual removal; evidence of two is required.

Outcome 3

Describe preservation methods used on hides or skins in leather manufacture.

Performance criteria

- 3.1 Describe preservation methods used on hides or skins in terms of process technique and effectiveness for different storage requirements.
 - Range preservation includes but is not limited to temporary preservation, wet salting, pickling.

Outcome 4

Describe the features of classification systems used to grade hides or skins in leather manufacture.

Performance criteria

4.1 Describe features of hides or skins that are used as the basis for grading or classifying raw or pickled material.

Range weight, size, age, substance; evidence of three features for hides or skins is required.
