Guidance Information

- 1 Definitions
Escort refers to both the person who escorts, and the process by which the escort is carried out;
The term *airport* refers to aerodrome as per Civil Aviation Rules.
- 2 Escort of people may include – people carrying cash, prisoners, VIPs, high-value freight escorter, contractors, cash handlers, medical and emergency services.
- 3 Reference to *enterprise procedures* means that all activities must comply with the requirements contained in the current airport exposition, current airport company manuals and procedures, and any relevant legislative and/or regulatory requirements, which may include but are not limited to: Civil Aviation Act 1990, relevant Civil Aviation Rules, New Zealand Defence Force (NZDF) Policy.

Outcomes and performance criteria

Outcome 1

Coordinate the escort of people at an airport.

Performance criteria

- 1.1 Coordination of escort ensures passage of people through the airport in accordance with enterprise procedures.

Range may include but is not limited to – crowd control, security clearances, route planning, provision for equipment, provision for contingencies, protocols.
- 1.2 The escort is conducted via a pre-arranged route in accordance with enterprise procedures.

- 1.3 Personal presentation of the escort conforms to enterprise procedures.
- Range may include but is not limited to – dress, identification established and/or visible.
- 1.4 The protocols established at pre-escort briefings are adhered to throughout the process in accordance with the status of the people escorted.
- Range may include but is not limited to – Ministry of Foreign Affairs and Trade, Māori cultural welcome, honour guards, handshake, NZ Police, security services, military personnel, segregation from public, segregation from media, crowd control, group control, corrections escort, undertaker, customs and immigration requirements, VIP vehicles.
