#### **Guidance Information**

1 Definitions

Aerodrome means any defined area of land or water intended or designed to be used either wholly or partly for the landing, departure, and surface movement of aircraft; and includes any building, installations, and equipment on or adjacent to any such area used in connection with the aerodrome or its administration; The term *airport* refers to aerodrome as per Civil Aviation Rules.

- Reference to *enterprise procedures* means that all activities must comply with the requirements contained in the current airport exposition, current airport company manuals and procedures, and any relevant legislative and/or regulatory requirements, which may include but are not limited to: Civil Aviation Act 1990, relevant Civil Aviation Rules, New Zealand Defence Force (NZDF) Policy, and the Fire and Emergency New Zealand (Fire Safety, Evacuation Procedures, and Evacuation Schemes) Regulations 2018.
- This unit standard may be assessed against in an aviation workplace in real or simulated situations, or in a training environment if simulated workplace conditions are able to be provided that reflect the standards of an aviation workplace.

# Outcomes and performance criteria

## **Outcome 1**

Respond to an aircraft emergency.

Range

emergencies may include but are not limited to – crash on the airfield, crash off the airfield, full emergency, local stand-by, aircraft security incident, unlawful interference.

### Performance criteria

1.1 Response to an aircraft emergency conforms to Aerodrome Emergency Plan.

1.2 Emergency responses are logged in accordance with enterprise procedures.

#### Outcome 2

Respond to an emergency in an airport building.

Range emergencies may include but are not limited to – fire, bomb threat (including unattended baggage), terrorist, civil emergency.

## Performance criteria

- 2.1 Response to an emergency in an airport building conforms to evacuation plan based on Fire and Emergency New Zealand (Fire Safety, Evacuation Procedures, and Evacuation Schemes) Regulations.
- 2.2 Response to an emergency in an airport building conforms to Aerodrome Emergency Plan.
