Outcome 3

Supervise the loading of materials at an extractive site.

- 3.1 Supervision ensures that loading machine is operated in compliance with industry guidelines.
- 3.2 Supervision ensures that load is placed in truck in accordance with driver's instructions.
- 3.3 Supervision ensures that stockpile base is left undisturbed.
