Guidance information

- 1 Definitions
Job specifications refers to the standard requirements of the job being undertaken.
Workplace policies and procedures refers to the documented procedures and policies providing guidelines of the tasks and activities carried out in the workplace.
This typically includes relevant health and safety requirements to eliminate hazard/risk in the workplace.
- 2 Evidence of a hinged door, a flush hatch, a sliding hatch, and a cockpit locker is required.
- 3 All work practices must meet recognised codes of practice and workplace policies and procedures (where these exceed code) for personal, product, and workplace health and safety, and must meet the obligations required under the Health and Safety at Work Act 2015, Health and Safety in Employment Regulations 1995, and Resource Management Act 1991, and any subsequent amendments.
- 4 Boat joinery maybe constructed using the exterior designs and working drawings supplied by the employer or any other party.

Outcomes and performance criteria

Outcome 1

Determine requirements to construct exterior boat joinery in timber.

Performance criteria

- 1.1 Working drawings are verified in accordance with job specifications.
- 1.2 Construction requirements are determined from inspection of working drawings, exterior designs plan, and the boat.

- 1.3 Construction method is determined in accordance with job specifications and exterior designs.

Outcome 2

Prepare materials and equipment to construct exterior boat joinery.

Performance criteria

- 2.1 Sketches and templates are developed in accordance with working drawings.
- 2.2 Materials and equipment are prepared in accordance with job specifications.
- Range materials – timber, adhesives, fastening.

Outcome 3

Construct exterior boat joinery in timber.

Performance criteria

- 3.1 Exterior boat joinery is constructed in accordance with job specifications and exterior design plan.
- 3.2 Completed exterior boat joinery is checked and remedial action is taken if required to ensure quality finish and job specifications are met.
